Medical Assistance Programs

Medical assistance, also called Medicaid, MA, or Forward Health is an umbrella term for many healthcare programs through the State of Wisconsin. It covers medical care, including inpatient and outpatient services, vision, dental, hearing, medical transportation and prescription drug assistance for individuals who meet eligibility criteria. Medical Assistance can be backdated up to three (3) months and is always the payer of last resort. **Apply with Western Region for Economic Assistance at 1-888-627-0430.**

Badgercare+

Badgercare+ is for individuals under age 65 who are not Medicare eligible and are within the household income limit*. Badgercare+ eligibility does not count assets.

*Parents and/or caretaker relatives of children may be eligible for Badgercare+

Monthly income limits (childless adult)	\$1,304.17	\$1,762.50

(Children under age 19 and pregnant women with income above the limit can become eligible by meeting a deductible)

Elderly, Blind or Disabled (EBD) Medicaid

EBD Medicaid is for individuals who are 60 or older, blind, or disabled.

SSI Medicaid

Eligibility for this program is determined by the Social Security Administration.

Categorically Needy Medicaid

Eligibility for this program is based on income, assets and shelter expenses.

Monthly income limits	\$1,050.78	\$1,582.05
Asset limits	\$2,000.00	\$3,000.00

Medically Needy Medicaid (Medicaid Deductible)

This program compares income and medical expenses when determining eligibility. The deductible amount for a 6-month period is the approximate difference between the applicant's monthly income and the medically needy income multiplied by 6.

Asset limits	\$2,000.00	\$3,000.00

Medicaid Purchase Plan (MAPP)

This program is for individuals who have a disability determination and have paid or in-kind work activity. Some individuals may have to pay a premium.

Monthly income limits	\$3,260.43	\$4,406.25
Asset limits	\$15,000.00	n/a

Home and Community Based Services Waiver Program

This program helps people to live in their own home or in the community and is for individuals 18+ who meet eligibility. This program counts income and assets for eligibility.

Contact the ADRC for functional and financial eligibility criteria.

Rules for counting income and assets can vary by program.

MEDICARE AND PRESCRIPTION DRUGS

Medicare Savings Programs

Medicare Savings Programs (MSP) reduce the cost of Medicare. **Individuals who qualify for MSP also qualify for Extra Help (prescription assistance).**

QMB

Qualified Medicare Beneficiary – State of WI pays for Medicare premiums, deductibles and copays. Does not include vision or dental benefits. (this is not full benefit Medicaid). Coverage begins the month after an individual is approved.

SLMB

Specified Low-Income Medicare Beneficiary – State of WI pays for the Medicare B premium. Coverage can be back dated 3 months.

Asset limits	\$9,660	\$14,470

SLMB+

Specified Low-Income Medicare Beneficiary – State of WI pays for the Medicare B premium. Coverage can be back dated 3 months. You **cannot** have SLMB+ and full benefit Medicaid.

Extra Help

The Extra Help Program helps Medicare beneficiaries afford their prescription drugs with lower copays and costs. Individuals who qualify for Medicare + Medicaid (or a MSP) will automatically receive Extra Help.

This program offers prescription drug and vaccine (pharmacy-administered) coverage for Wisconsin seniors who are 65 and older. Individuals can apply as early as the month of their 65th birthday with coverage beginning the following month. **The enrollment fee is \$30 for 12 months of coverage.** Coverage is considered creditable or as good as Medicare's prescription coverage. In some cases, it is beneficial to have drug coverage through both Medicare and SeniorCare.
