The Clark County Highway Commissioner will receive quotes until 10:00 A.M., March 25th, 2024 at the office of the Clark County Highway Department, 511 W South Street, Loyal, WI. 54446.

Quotes shall be submitted on the department form and delivered to the Clark County Highway Commissioner. Mailed quotes shall be clearly marked on the outside of the envelope, 2024 Culverts. Faxed quotes are NOT accepted. Quotes can be emailed to highway.department@co.clark.wi.us.

Quotes shall conform to the requirements of the Instructions, Terms, Conditions and Specifications.

Funding for services and materials may include but not be limited to projects involved with GTA, TAX LEVY, STP RURAL, CHI-D, CHI, RMA, DMA and PBM.

The Clark County Highway Committee reserves the right to adjust quantities, reject any or all proposals or to waive any irregularities in any proposals, and to accept any proposals or parts of various proposals, which will best serve the interest of Clark County.

PROJECT SPECIFICATIONS

Clark County Highway Department is seeking a responsible and qualified vendor to supply culverts pursuant to the following specifications:

1. Price shall be valid through the completion of this order with the option to extend contract for additional purchases; agreed by buyer and seller.
2. Price are F.O.B. Destination Clark County Highway Department Owen, WI. Pipe delivered during normal business hours of 7:00 a.m. to 3:00 p.m. Monday thru Thursday, except for holidays.
3. All material shall meet or exceed State of Wisconsin, Department of Transportation, specifications as described in the current issue of "State of Wisconsin Department of Transportation Standard Specifications for Highway and Structure Construction", including applicable supplements. Explain any deviation to specifications with your proposal.
4. High Density Polyethylene (HDPE) Culverts
 - a. Corrugated, Dual Wall
 - b. Smooth Interior meeting Manning's "n" value for use in design shall be 0.013 or less
 - c. Pipe shall be joined using a bell & spigot
 - d. Soil-tight gaskets and shall meet the requirements of ASTM F477
 - e. Gaskets installed by manufacturer and covered with a removable protective wrap
 - f. Joint lubricant supplied from the manufacturer
5. Galvanized Corrugated Metal Arch Culverts
 - a. Corrugated culverts shall have 2 $\frac{2}{3}$ " x $\frac{1}{2}$ " or 5" x 1" corrugations depending on size
 - b. Spiral culverts shall be 4-rib with re-rolled ends to accommodate bands
 - c. Culverts are to be one continuous constructed piece with no bands
