The Clark County Highway Department is considering an undertaking located on County W from STH 73 to USH 10 (see attached project location map). The proposed undertaking will include pavement replacement of 6 miles of County W.

Purpose:

The purpose of the proposed project is to address the deteriorating pavement in order to provide a safe and efficient transportation system.

Need:

The following needs have been identified for the proposed project limits of County W:

1. The existing pavement shows signs of deterioration and failure including longitudinal and traverse cracking. The pavement was assessed with a PASER (Pavement Surface Evaluation and Rating) pavement condition rating of 5-Fair. The PASER scale is a 1-10 rating system for road pavement condition that uses visual inspection to evaluate pavement surface conditions. A rating of 10 indicates a perfect pavement and a rating of 0 indicates pavement failure. Numeric PASER ratings can be consistently equated to pavement condition. The existing pavement deterioration will reduce ride quality, require increased maintenance, and lead to a reduction in the pavement life.

Proposed improvements include:

1. The pavement structure would be replaced by pulverizing and relaying 6-inches of the existing pavement and base and placing 4.5-inches of asphalt on top.
2. Maintain the existing horizontal alignment and the vertical profile will be raised slightly
3. The existing typical section has 11' paved driving lanes with 3' gravel shoulders. The proposed typical section is 11' paved driving lanes with 1' paved shoulder and 2' base aggregate dense shoulder.
4. Pavement markings and permanent signs will be replaced as part of the project.

Proposed traffic impacts:

Construction is tentatively scheduled for 2026. County W will remain open to traffic. Construction will take place under single lane closures via flagging operations. Driveway accesses within the project limits will be maintained during construction. Temporary driveway closures will be necessary during some construction activities. The contractor will contact property owners prior to closing a driveway.

Real Estate:

No real estate acquisition is anticipated for this proposed project.
