Immunization Requirement Changes

Changes to Wisconsin Admin. Code Ch. DHS 144

This update includes new additions since last newsletter update (see previous newsletter for more information).

A public hearing for the Joint Committee for Review of Administrative rules, including DHS 144 Relating to Immunization of Students, is scheduled for **Tuesday, March 7, 2023** at 11:00am. This includes the committee hearing and considering testimony related to the possible suspension of portions of DHS 144. See the hearing announcement for further details.

What does this mean? Legislature can suspend the changes after holding a public hearing (something similar happened back in 2017 when changes were proposed). We will keep you all updated as we learn more. We are apologizing in advance to the tough spot this puts everyone in when trying to communicate these changes out to the community in preparation for the 2023-2024 school year.

Reminders:

- Wisconsin state statue continues to permit waivers to vaccination for reasons of health, religious, or personal conviction.
- There continues to be no requirement for seasonal flu or COVID-19 vaccination. These remain strongly recommended by leading health experts, including DHS, CDC, AAP, ACOG, AAFP, and more.



Immunization Requirement Changes

Varicella (Chickenpox) History

There has been some recent confusion on the immunization requirement changes in regards to grandfathering of varicella (chickenpox) history. Previously, parental report of history of varicella was acceptable. The new immunization requirements does not accept parent history, but requires confirmation from a qualified health care provider.



Schools - At this time, it is still being clarified if school age children with a previous parental report of varicella history are grandfathered in or not.

Child Care - At this time, the following has been confirmed:

- Children at your center who had parental report of chickenpox disease before February 1, 2023 are grandfathered in. They may continue to use parental report of chickenpox throughout their attendance at your center.
- Children who are new enrollees at your center must fill out a <u>Child Care Immunization</u> <u>Record</u> form. Parental report of chickenpox documented at a former center will not carry over when enrolling in a new center.

Large Increase in Positive Strep Throat Cases

Reports from Marshfield Clinic

Marshfield Clinic Health Systems (MCHS) updated area health departments recently on a large increase in positive strep throat cases within their system. In February alone, MCHS reports 158 positive cases of strep throat, with a 50% positivity rate, in just the Marshfield Clinic pediatric department.

According to the Wisconsin Childhood Communicable Disease Wall Chart linked above:

- The incubation period for strep throat is 2-5 days (period of time from exposure to symptoms).
- Individuals should be excluded from school or group for 24 hours after initiation of appropriate antibiotic therapy and fever resolved.



Toxic Shock Syndrome

Increased Reports in Wisconsin Associated with Super Absorbency Tampons

As of February 7, 2023, DHS had identified four cases of Toxic Shock Syndrome (TSS) related to super absorbency tampon use since July 2022. In typical years, 0-1 cases of TSS are reported to DHS. The last year that more than one case of TSS was confirmed was 2011. The recent cases were identified in adolescent girls and young women, who were between the ages of 13 and 17. This is the largest number of reported cases in over 10 years.



Symptoms of TSS include sudden fever, vomiting, diarrhea, dizziness, muscle aches, low blood pressure, rash, and shock with multi-organ dysfunction. Appropriate tampon use includes using the lowest absorbency tampons, changing tampons every four to six hours, and avoiding use of tampons overnight. You can find more information here.

School-Based Mental Health (SBMN) Grant Application

Grant Competition Now Open

The State SBMH Services Grant Program is a two-year grant aligned with the Wisconsin biennial budget. The next grant cycle runs from July 1, 2023-June 30, 2025. Applicants may apply for up to \$75,000 per year of the two-year grant. All grant applications submitted via the application link by **4:00pm on May 5th, 2023** will be reviewed.



The SBMH services grant provides funding to support the development and sustainability of Comprehensive School Mental Health Systems (CSMHS). A CSMHS provides an array of supports and services that promote school climate, social and emotional learning, and mental health and well-being, while reducing the prevalence and severity of mental illness. \$2.75M in Grants Available for MCH Programs and Projects Maternal and Child Health (MCH)



Municipal, tribal, county, and governmental entities, school districts, and nonprofit, nongovernmental organizations in Wisconsin are eligible to apply for funding to develop and implement strategies to address mechanisms by which social determinants impact Wisconsin's significant disparities in maternal and child health outcomes.

Applicants can apply for grants for up to \$250,000 for projects to be completed within 18 months, from July 1, 2023, through December 31, 2024. The deadline to apply for these funds is **5:00pm CST on March 6, 2023**. You can find more information <u>here</u>.

All Wisconsin households can now receive two free COVID-19 self-testing kits per month. Each test kit includes a total of five self-tests. Ordering reopens on the 1st of every month for those who have placed an order the month before. Once test kits are ordered, delivery is expected to take 1-2 weeks.

- Enrolled or eligible for Medicaid.
- Do not have health insurance.
- Have health insurance, but vaccines are not covered, or only some vaccines are covered.
- American Indian or Alaska Native

Available vaccines and costs below, to any adult regardless of insurance status.
