Immunization Requirement Changes

Changes to Wisconsin Admin. Code Ch. DHS 144



For the first time since 2008, Wisconsin Admin. Code Ch. DHS 144, Immunization of Students, which outlines immunization requirements for child care centers and school entry, is now updated to better align with national vaccine recommendations. Child care requirements are **effective February 1, 2023**, while implementation of the updated school entry requirements will **start with the 2023-2024 school year**.

iHealth COVID-19 At-Home Test Kits

Expiration Dates May Have Been Extended



It is recommended that any iHealth test kits do not get thrown away, even if they have reached their expiration date, in case expiration dates are extended again.

K-12 COVID-19 School Testing Program Winding Down

Last Date to Order COVID-19 At-Home Test Kits Set

DHS is announcing the phased step-down of the K-12 COVID-19 School Testing Program. The last date for ordering at-home antigen test kits will be June 15, 2023. There will be no testing support for summer schools or camps from DHS in 2023. Schools with summer programs are encouraged to request at-home test kits to distribute to students and families. Schools that wish to continue to test with vendors (like the school testing program) are encouraged to establish their own agreements using school/district funds. Communicable Disease Outbreaks

• DHS reminds schools to partner with local health departments by proactively reporting significant illness among students/staff, as outlined in the state's communicable disease reporting requirements. Reporting helps inform health departments so they can take action to protect students and the larger community. Schools are also asked to regularly communicate with parents to keep them informed about illnesses.

Non-Reportable Communicable Diseases

 Some examples of non-reportable (meaning they do not need to be reported to the CCHD) communicable diseases and/or conditions include: head lice, bed bugs, scabies, etc. The best way to find information about these diseases and/or conditions is to visit <u>DHS</u> and <u>CDC</u> websites. Otherwise, you can visit the CCHD website (Pests, Ticks & Nuisances).

Vaccines for Children (VFC)

Children through age 18 can be vaccinated, free of cost, if they meet any of the criteria below:

- Enrolled or eligible for Medicaid.
- Do not have health insurance.
- Have health insurance, but vaccines are not covered, or only some vaccines are covered.
- American Indian or Alaska Native

Available vaccines and costs below, to any adult regardless of insurance status.


