#### **Puberty Educational Talks for 4th Graders**

#### **Provided by County Health Department Staff**

#### **Keeping and Disposing of Medications Safely**

#### **Medication Lock Boxes and Medication Deactivation Pouches**

Upon request, the Clark County Prevention Partnership is offering medication lock boxes and medication deactivation pouches to Clark County schools.

• Medication Lock Boxes: Each medication lock box is comprised of alloy steel, and can only be opened with a key or electronic passcode. Dimensions are 13" W x 4.4" H x 10" D. The Clark County Prevention Partnership would like to partner with each school district so that schools can have these available for distribution to families who need them. The purpose of these lock boxes is to promote safe medication storage and handling within households. Each school district may request up to 7 medication lock boxes. **Deterra Drug Deactivation and Disposal Systems**: To reduce the risk for unintended access to prescription medications, leftover opioids and stimulants should be properly disposed of. The Clark County Prevention Partnership would like to offer up to 35 Deterra pouches to each school district in Clark County. With the addition of water, each pouch is capable of permanently and irreversibly deactivating up to 45 pills, 6 ounces of liquid, or 6 patches. Pouches can then be disposed of in the normal trash. Click <u>here</u> for more information. These pouches may be distributed to families, or can be used internally to dispose of medications that have not been collected at the end of the school year. Pouches are also available to the public at 5 locations throughout Clark County. Click here for the locations.

#### **Improve Access to School Health Services**

CESA 6 will be hosting a webinar on the WI K-12 Telenursing Project that is being made available to schools in 2023-2024. The webinar will be held on **Thursday, August 3rd at 2:00pm**. The webinar will help explain an additional opportunity to improve access to school health services as part of the workforce development grant.



The project will fund telenursing activities in Wisconsin focused on increasing access to school health services to support existing school health personnel and provide services to schools that lack the resources to fund full-time or part-time staff to address school health concerns. The funding is coming through DHS.

# Seal-A-Smile

Clark County Seal-A-Smile (SAS) is a school-based oral health program with a focus on dental sealants.

Clark County SAS provides FREE oral health services for ALL children in grades Kindergarten through 8th grade, regardless of insurance status, in participating schools.

#### **Oral Health Services**

Oral health services are provided by a licensed professional on various dates throughout the school year!
Oral health services include:

- Teeth Screening & Cleaning
- Teeth Brushing Education
- Fluoride Treatment(s)
- Dental Sealants (If Applicable)

#### **Consent Form**

Parent/guardians can sign-up their child to receive SAS services at their school!

Paper consent forms are sent out at the beginning of the school year.

Multiple consent forms are acceptable. SAS staff would rather have multiple consent forms for each student, than none at all!





# **Reproductive Health Services**



#### **Nurse Practitioner (NP)**

**By Appointment Only**: A NP is available on the 4th Wednesday of each month! Services include (not an all-inclusive list):

- Annual Reproductive Health Exams (PAP, Pelvic & Clinical Breast Exams)
- Comprehensive STI Testing & Treatment Services (HIV & Syphilis)
- Long-Acting Reversible Contraception (Intrauterine Devices & Nexplanon) Insertion & Removal

#### **Education Available to Schools?**

Upon request, CCHD staff members can provide **puberty** education (45 minutes - 1 hour class period) to 4th or 5th graders (recommended for 4th graders) in Clark County.
