

1 WHEREAS, the Clark County Sheriff's Department provides an array of services, including services of
2 process, writ execution, and conducting sheriff sales; and
3
4 WHEREAS, Wis. Stat. 814.70 defines the fees that the Sheriff's Department may charge and collect for
5 such services unless higher fees are approved by the Clark County Board of Supervisors (Board) pursuant
6 to Wis. Stat. 814.705; and
7
8 WHEREAS, the actual cost to carry out services by the Sheriff's Department exceeds the fees defined in
9 Wis. Stat. 814.70 due to inflation, labors costs, and market changes; and
10
11 WHEREAS, the Board may establish fees that closer reflect the actual cost of providing such services
12 pursuant to Wis. Stat. 814.705; and
13
14 WHEREAS, the Board approved Resolution 25-6-14 in June 2014 that currently defines the fees that the
15 Sheriff's Department may charge and collect for providing services; and
16
17 WHEREAS, after reviewing the fees associated with sheriff sales, the sheriff sale fees need to be adjusted
18 to reflect the current cost of such service as set forth below.

20 NOW, THEREFORE BE IT RESOLVED, the Clark County Board of Supervisors hereby approves
21 amendments to the Sheriff's Department fees (in bold) to be charged and collected, subject to policy, as
22 set forth below:

24 Process Fee: \$60.00
25 Attempt Fee: \$60.00
26 Process Fee for Rush Services: \$60.00
27 Copy Fee for Second Person: \$18.00
28 Mileage: Current county rate
29 **Sheriff Sale Fee: \$150.00**
30 **Posting Sale: \$75.00**
31 **Conducting Sale: \$75.00**
32 **Note: If there will be multiple sales of parcels within each sale, the fee is \$75.00 per sale.**
33 Huber Fee: \$18.00
34 Fingerprinting: \$10.00

36 BE IT FURTHER RESOLVED, for the services of any writ or other process, the Sheriff's Department
37 shall charge and collect a fee per hour equal to the actual cost to Clark County for wages and benefits,
38 including potential overtime, plus any and all necessary expenses that are incurred thereby.
